R8 Membership status

Membership year 2013 ended (in August) with a slight decrease in higher-grade members in R8. Since then, evolution has been positive and now we are at almost the same number of HGM as last year. Growth in membership has been caused by student members mainly. We need to focus in retaining higher-grade members, as well as recruiting them.

Incentives for using the MGM program

We all know that the Member-get-a-member (MGM) program is an excellent way of recruiting new members, as word of mouth is the best way of expanding awareness about IEEE. But in addition, it can bring benefits to your Section in the form of financial incentives. The Sections with the top 5 recruiters in MGM in the Region get an extra rebate after membership year end. This year the top 5 recruiters were:

- 1. Meher Ben Houria, who awarded Tunisia Section an extra \$500 rebate
- 2. Rami Kiwan, who awarded Lebanon Section an extra \$400 rebate
- 3. Yasemin Karadana, who awarded Turkey Section an extra \$300 rebate
- 4. Ghaleb Dwikat, who belongs to the Region but not to a Sections
- 5. Brett Terespolsky, who awarded the South Africa Section an extra \$100 rebate

Encourage your members to make use of the MGM program and get extra rebate for your Section next year. Of course, they will receive benefits too. Higher grade members receive \$15 foe every HGM they recruit (\$5 if they recruit en e-member). Students and GSMs receive \$15 for each HGM recruited, or \$2 for each Student or GSM recruited.

R8 program to increase membership in small Sections

The R8MD Subcommittee initiated a program in 2010 to increase the membership of small Sections having less than 200 professional members. We want the small Sections to become bigger and stronger organizations with more volunteers and more activity. This initiative has been continued in 2011, 2012 and 2013. The best way to maintain and enhance programs and services on the Regional and Section level to our members while holding down or reducing the member cost is to increase the number of members.

Here are the rules:

All sections with less than 200 professional members (w/o Graduate and undergraduate students) that raise their membership by 10 professional members or more within the 2014 membership year (16 August 2013 - 15 August 2014) will be qualified for a financial incentive of 10 dollars per additional Professional member.

Professional Members include e-members and members using the reduction of dues according to the Special Circumstances. "Migrating" members (i.e. members who moved from one region/section to another) would not count.

Example for small Section membership increase and rebate:

- Professional/Higher-Grade , Full Dues Paying Members (w/o graduate and undergraduate students) on 15 August 2013: 61

- Professional/Higher-Grade, Full Dues Paying Members (w/o graduate and undergraduate



students) renewed until 15 August 2014: 52 - Professional/Higher-Grade, Full Dues Paying Members (w/o graduate and undergraduate students) recruited until 15 August 2013: 26 Increase 52+26-61=17 **Rebate for the Section** 17x10=170 USD

Update on conferences notices

Since May 2013 we are sending out conference notifications to all section MD officers summarizing the conferences taking place in each section between 3 and 6 months from the notice. These notices are aimed at making it easier for the MD officers to keep track of the conferences in their Section and to minimize their work in contacting the organizers and reminding them that they should include an IEEE membership development booth, deliver promotional materials, and reply to queries from potential new members. They can count on the Section MD team to assist in these matters.

On average, 30-40 notices are sent out every month covering over 100 conferences. The IEEE conferences in our Region offer a great recruitment potential for new members. Please encourage and support the conference organizers in your Section to support the IEEE's recruitment effort.

Potential for membership per country

Not all Sections or countries are equal. We have very large and quite small countries in the Region, and their particularities make them unique, among other things in the number of members. But the penetration rate of IEEE membership in every country is very diverse. There are countries where the number of members relative to population is still very low, having big potential to grow.

The following table summarizes the number of IEEE members in every country (September 2013), its population, and the ratio IEEE members/million inhabitants. As you can see, in R8 the average penetration is about 50 members per million inhabitants.

In the table, countries marked in red colors are those who have penetration below average, and those in green are the ones above average.

In the two tables that follow, countries are sorted by penetration rate. We can notice that there is potential to grow in most African and Middle East countries, and some European ones.

Use the table and the data inside with caution, there are of course many more particularities in countries and associated Sections, but the numbers there can be helpful to know whether you can spend your efforts in recruiting members or on retaining them (or ideally, both).
