1. Procedural – Call to order and welcome (Piuri)

Region 8 Director Vincenzo Piuri calls the Committee to order at 08:05 h (Eastern European Time, UTC+2) and opens the 120th IEEE Region 8 Committee meeting welcoming all attendees.

2. Procedural – Housekeeping (Karadzinov)

Region 8 Secretary Ljupco Karadzinov presents the housekeeping rules, the meeting schedule and the social events. He reminds the participants that tomorrow starts the Summer Time (UTC+3) which is the reason for starting the Day 2 of the meeting at 09:00 h. Saifur Rahman, IEEE President & CEO, presents his 2023 IEEE Presidency Theme and 6 points vision, synergy among IEEE's areas in focus; and gives a special emphasis on the IEEE Ad Hoc Committee on Coordinating IEEE's Response to Climate Change activities. After the presentation Rahman answers questions from the R8 Committee members.

Thomas Coughlin, 2023 IEEE President-Elect, presents his plans for IEEE in 2024 including the priorities and the 6 goals. After the presentation Coughlin answers questions from the R8 Committee members.

8. Discussion – IEEE Executive Director address (Muirhead)

Sophie Muirhead, IEEE Executive Director & COO, presents her report and the IEEE update. Starting her COO position this year, she feels super thrilled and humbled to present the first presentation at an IEEE Region meeting. At the beginning Muirhead presents her personal and professional background. Then she presents the 2023 Executive Director goals, risks and key opportunities. After the presentation questions from the audience are answered.

9. Discussion – IEEE MGA Chair & IEEE Director address (Gostin)

Jill Gostin, IEEE Vice President, MGA, presents her report on the MGA Initiatives/Priorities 2023, Region Realignment, the 2020-2025 MGA strategic plan and the 2023 priority projects. After the presentation Gostin and Muirhead answer questions from the audience.

Jill Gostin, IEEE Vice President, MGA, presents on behalf of Cecelia Jankowski, MGA Managing Director, their joint presentation on the latest IEEE membership statistics, membership dues, reduced membership fees for special circumstances & developing nations, FUTURE50 student dues discount offer outcome, how the membership dues are collected & applied, and the assessment allocations. After the presentation Gostin answers questions from the audience.

30. Procedural – Call to order (Piuri)

Region 8 Director Vincenzo Piuri calls the Committee to order at 09:07 h (Eastern European Summer Time UTC+3) and opens the second day of the 120th IEEE Region 8 Committee meeting.

31. Discussion – REACH program (Kaabunga/McKenna)

Kelly McKenna, REACH Sr. Program Manager, presents the IEEE REACH free open education resource program for secondary educators' interdisciplinary program, developed for Social Studies Teachers and STEM teachers, an IEEE foundation program. The program has 50% users from R8 with a UNESCO pilot program in Uganda.

32. Discussion & Motions – Vice-Chair Students Activities report (Aliyu)

Abdullateef Aliyu, R8 Vice-Chair Students Activities, presents the team, the R8 student activities goals, membership statistics and OUs update, SAC activities highlights and timeline. Then he invites the Chairs of the AdHoc committees under his portfolio to present their respective activities:

33. Discussion – R8 Section vitality and development (Zaic)

Matej Zajc, Section Vitality & Development Committee Chair, presents the proper Sections and other OUs elections process and timeline, and reminds the participants that elected officer's term start/end date should be 1 January/31 December. All officers shall not serve in any one position, in any single organizational unit, more than 6 years. After the presentation Zajc answers questions from the audience.

Zajc presents a motion regarding approval of the Nigeria South-East Subsection, with the Nigeria Section as a parent. Piuri and John Funso, Nigeria Section Chair, explain the background and petitioning process.

Motion: Approval of Nigeria South-East Subsection

Resolved that the Region 8 Committee approves the formation of Nigeria South-East Subsection, with Nigeria Section serving as a parent, and with boundaries corresponding to the boundaries of the five states (Abia, Anambra, Ebonyi, Enugu, and Imo), colored in the map of Nigeria below.



The motion passes unanimously.



Coffee Break [10:34-11:15]

Before the coffee break, Vincenzo Piuri, presents to Lucian Toma, Romania Section Chair, the plaque of the 2021 Region 8 Section Award for Industry Engagement, as the most active industry engagement Section of 2021 and in recognition of the excellent services to its members. The plaque was not possible to present earlier due to the Covid-19 pandemic.

34. Discussion – R8 Diversity, equity and inclusion (Abandah)

Gheith Abandah, R8 DEI Committee Chair, presents volunteers diversity and inclusion analysis at the R8 level and at the Section level, regarding member's grade and gender. Only 17 out of 59 Sections reported on DEI (Fall 2022). After the presentation Abandah answers questions from the audience.

35. Discussion & Motions – Sections Congress 2023 (Stasopoulos)

Costas Stasopoulos, SC2023 Region 8 Coordinator, presents information about the forthcoming Sections Congress 2023 in Ottawa, Canada, 11-13 August 2023: overall schedule, program session overview (breakout and ignite sessions), what is covered by MGA or R8 for primary and non-primary delegates, and the 3 steps how to proceed with the SC2023 Registration (SC registration, hotel booking, air plane ticket). Stasopoulos also presents information about the next IEEE Region 8 Committee Meeting that will be held on 11 August 2023 before the opening of the SC23, in the Lord Elgin Hotel, Ottawa. Karadzinov, R8 Secretary, informs that if the plane ticket is more expensive than US\$ 1,500, the R8 volunteers shall ask for help and approval from the R8 Assistant Treasurer Pascal Lorenz <u>lorenz@ieee.org</u>. Jastrzebski, R8 Treasurer, explains the Concur codes for expenses reimbursement that can be done in 2 installments, first one now, after plane ticket purchase, the second one in August after returning home. Rob Anderson, R7 Director informs that obtaining entry visas to Canada is a lengthy process, and urges attendees to apply ASAP. Other numerous questions from the audience are answered by Stasopoulos, Piuri, Karadzinov and Jastrzebski.

Stasopoulos continues with the explanation of the SC2023 Recommendation Process and presents the eleven recommendations received from the R8 volunteers. After a short discussion, it is unanimously agreed to merge the first and the second into a single one. Voting takes place to choose the three most important for R8 to be sent to the SC23.

36. Discussion – Humanitarian Technologies Board address (Herbert)

Lwanga Herbert (present on-line), 2023 IEEE Humanitarian Technologies Board Chair, gives an overview of this board vision and mission, the activities through the IEEE Special Interest Groups on Humanitarian Technology (SIGHT) feet-on-the-ground initiative, and the benefits and the opportunities for the individual IEEE members. Questions are answered after the presentation.

37. Discussion – Region realignment: Zone Representative (Luque)

Antonio Luque, R8 Past Director, reports on the current status of the IEEE Region realignment process and presents the governance changes in R8 related to Zones that have to be made in regard to MGA OpMan 9.2. Highlights:

- Realignment of the Regions was approved at MGAB and BoD in Nov 2022
- R10 splitting into new R10 and R11, R1 and R2 merging into new R2, effective 1 Jan 2028
- Zones in R10 (until 31 Dec 2027) and in R8 (forever in principle)
- Zone representative as voting member of MGAB
- Zone representative is a position at MGAB, where R8 will have two members according to its size, and where geographical diversity will be guaranteed thanks to the Zone distribution
- MGA OpMan 9.2
 - \circ ~ The Zone boundaries shall be approved by the MGA Board.
 - The method of appointment of Zone Representatives shall be specified in the Region bylaws.
 - The Region Director and Zone Representative shall originate from different Zones in their Region.
 - Region 8 shall have:
 - Zone 8.A: Europe, Greenland, Turkey, Israel, and the countries of Asia north of Iran, west of Pakistan, north and west of Afghanistan, and north of Mongolia and China
 - Zone 8.B: Africa and the countries of Asia located west of Pakistan and not included in the previous definition.
- In 2022 the R8 Committee decided to extend the term of the Zone representative until the end of 2024.
- The Region shall appoint the Zone representative using a method specified in our Bylaws.





• A new appointment will be needed during 2024 and it would be good to have the method of election already in the R8 Bylaws.

Discussion takes place to:

- Collect the feelings of the R8 Committee and other volunteers present about all processes related to the Zone Representative in the Region.
- Prepare a proposal for changes to the R8 Bylaws and the R8 Operations Manual by the OpCom for discussion and potential approval during the 121st R8C meeting in Ottawa (11 Aug 2023).

Conclusion: A consensus is reached that the R8 Zone Representative shall be a member of the R8 Committee being elected in a similar procedure as the R8 Vice-Chairs by the R8 Committee voting members.

38. Procedural – Next meeting (Piuri)

Vincenzo Piuri, Region 8 Director informs that the next in-person 121st R8 Committee meetings will be held on Friday morning, 11 August 2023, before the opening of the SC23, in the Lord Elgin Hotel, Ottawa. As this meeting is earlier than usual (Oct/Nov) in the year, if needed there may be another third R8 Committee meeting, however only on-line as there is no budget for that.

Then Piuri invites Section Chairs to express willingness to host the next year 2024 R8 Committee in-person meetings. Bahrain Section Chair Ali Zoalit expresses willingness to organize the 2024 Fall R8 Committee meeting in Bahrain. Discussion follows regarding the dates of the 2024 Spring R8 Committee meeting to have it in early March to avoid the holy Muslim month of Ramadan, which is important for the R8 volunteers from about 15 Sections.

39. Procedural – Old business (Piuri)

No issues reported under this agenda point.

40. Procedural – New business (Piuri)

No issues reported under this agenda point.

41. Procedural – Adjourn (Piuri)

Region 8 Director Vincenzo Piuri invites all participants to join him and form a circle in the middle of the room holding connected extension power cords with a light bulb at the end. Then he closes the meeting with a thankyou speech to all R8 volunteers for their dedicated work: "From my heart and my mind, thanks to all volunteers who participated in our Region Committee meeting. Thank you for this opportunity of working together and building our collective vision to guide activities in our Region. Thank you for being the conduit which brings the light of knowledge back to the local communities to promote the advancement of science and technology, to stimulate innovation, to make our collective vision a reality for the benefit of humanity, the environment, and all living beings! And thanks to all the volunteers who will work with you!" The meeting adjourns at 13:30 h (UTC+3).

Nigeria has an area of 923,769 km2 and with a population of over 230 million.

1. What was the motivating factor that led to forming this geographic unit? What member needs will be fulfilled as a result of forming this unit?

Nigeria is a big country. Nigeria covers an area of 923,769 square kilometers and a GDP per capita of \$2,060, according to the International Monetary Fund's World Economic Outlook database (October 2021). This economic reality makes it difficult for many members and student members to attend IEEE events, which are held in far-flung locations. With over 200 million, Nigeria is the most populous country in Africa and the world's sixth-most populous country. It is becoming practically difficult for one Section to coordinate the IEEE activities

in a big country like Nigeria. Nigeria is divided into six geo-political zones: North Central, North East, North West, South West, South East, and South-South. From observation, many volunteers do not attend IEEE events held outside their geo-political zone. This is because of the long-distance travel that is involved to attend such an event.
