#### Goals

Our Committee's mission is to inspire and enable the IEEE volunteers in the Region to carry out and support impactful humanitarian technology and sustainable development activities at the local level. In particular, our goals include:

- Connecting with humanitarian volunteers and building the optimal humanitarian team in the Region,
- Mentoring existing SIGHT groups and prospective groups,
- Increasing visibility of humanitarian activities within the Region,
- Encouraging reporting of activities via vTools by monitoring and reaching out,
- Raising awareness of ongoing HTB/SIGHT activities,
- Encouraging submission of HTB/SIGHT project proposals and proposals for funding of activities,
- Encouraging celebration of SIGHT Week/Day across the Region,
- Encouraging students and young professionals involvement in humanitarian activities,
- Organizing R8 Humanitarian Activities Congress when budget allows and collaborating in organizing humanitarian conferences,
- Recognizing exceptional SIGHT groups and volunteers,
- Supporting SIGHT groups activities and encourage them to participate in Regional humanitarian activities,
- Developing programs and initiatives to enable volunteer engagement in humanitarian activities,
- Reviewing and evaluating of the overall effectiveness of humanitarian programs,
- Recommending best practices as they relate to programs and projects,
- Evaluating of funding proposals for projects to be carried out at the local level,
- Collaborating and establishing partnerships with other IEEE OUs, with external organizations and other entities with similar goals on humanitarian projects.

Our KPIs focuses on the following areas:

- Increasing the number of SIGHT groups in the Region by at least 20%.
  - ✓ *Progress: 2 new SIGHT groups have been formed and 1 petition is pending.*
- Increasing SIGHT groups events reporting on vTools by at least 30%.
  - ✓ Progress: 113 events have been reported on vTools by R8 SIGHT groups.
- Continuing at least 3 of the Humanitarian Programs and Initiatives 2021-22.
  - ✓ Progress: 3 programs have been launched, and 2 programs are scheduled for Q3/4.
  - Launching at least 3 new Humanitarian Programs and Initiatives in the Region.
    - $\checkmark$  Progress: 1 program have been launched, 2 programs are scheduled for Q3/4, and 2 initiatives are underway.
- Coordinating and getting aligned with the newly established IEEE Humanitarian Technologies Board.

   *✓* Progress: 2 meetings have been concluded, and communication is on an ongoing basis.

- ► <u>SIGHT Groups Status:</u>
  - 32 groups in total:
    - 21 professional groups on Sections
    - 11 student groups on Student Branches
  - 1 new group since last report:
    - Higher I A Sciences & Technologies (ISSAT Sousse) SB SIGHT
  - 3 Sections have appointed Humanitarian Activities Chairs (*potential transformation to SIGHT groups*)

# ► <u>SIGHT Membership</u>:

- 4,404 active members as of June 2023
- YoY change: +1,435 members (+48.3%)

#### **Points of Concern**

- Some programs require handover during a crucial timing for the program execution.
- Social media and publicity coordination of the Committee to establish solid marketing plans and raise awareness of potential opportunities.
- In some cases, SIGHT projects closing should be completed under newly elected officers, which require a proper handover.
- Participation in programs such as Humanitarian Voices and Humanitarian Ambassadors Programs is important in order to increase awareness of humanitarian activities in the Region.

## **Proposals for Improvements**

- It would be beneficial for Sections to closely cooperate and monitor SIGHT groups projects progress as they are the financial responsible OU.
- Increase awareness of IEEE HTB/SIGHT and R8 HuAC programs and funding opportunities to help increase the level of impactful activities using technology appropriately to support local community needs.
- Sections without SIGHT groups could form one and start working on implementing SIGHT projects.
- Need for funding opportunities in two levels: (a) collaboration with Societies for joint activities and sponsorships and (b) Section support to SIGHT volunteers for traveling purposes whenever possible.

## **Programs and Initiatives**

## ► <u>Community Support Program</u>

Description: Provides support to R8 SIGHT Groups to implement projects that address local community challenges.

*Status:* Collaborating with HTB to monitor 2022 CFP funded projects status and to release <u>2023 R8/HTB CFP</u>; awards up to US\$6,000 for SIGHT projects with <u>submission deadline set at 31 August</u>. All R8 SIGHT groups are eligible to apply and all R8 Sections and SBs without SIGHT group if commit to form one by November 2023.

## <u>Connecting Humanitarian Experts</u>

*Description:* Quarterly webinars on humanitarian topics presented by an expert in the field in order to understand the humanitarian impact in achieving UN SDGs from an engineering and technical perspective.

Status: These sessions are organized in collaboration with R8 YPs. The first webinar was organized on 21 June.

### Humanitarian Ambassadors Program

*Description:* Supports and trains volunteers to increase awareness and knowledge about IEEE humanitarian opportunities, increase the impact of existing SIGHT groups, and encourage the establishment of new groups.

*Status:* Preparations for program launching have been completed. To be launched in the upcoming months in two periods; one for Sections and one for Student Branches.

### <u>R8 Humanitarian Activities Congress</u>

*Description:* Brings together R8 SIGHT group members to share results, lessons learnt and experience with peers across the Region, and to discuss and address various humanitarian and community development projects, as well as to promote the use of technology for social good.

Status: Under planning to be hosted virtually for this year.

#### ► <u>R8 Humanitarian Technologies Hackathon</u>

*Description:* Fosters competition amongst IEEE and SIGHT members, through their solutions to specific humanitarian challenges and targets tech proposals around specific UN SDGs.

*Status:* Theme confirmed (climate change) and structure finalized. Currently, raising awareness to SIGHT groups and sending invitations to judges. On the upcoming days, the call for participation will be launched.

#### ► <u>SIGHT Groups Accelerator Program</u>

*Description:* Provides existing SIGHT groups seed funding for the new year's activities based on their humanitarian efforts and activities of the past year to celebrate the success of their activities, provide funding to organize more activities, help evaluate their health status and promote good practices.

*Status:* Program has been renamed. Criteria and rules are defined. <u>A website page</u> has been created. Collaboration with SAC has been established to enhance its promotion.

#### SIGHT Groups Coordination Workshops

*Description:* Periodic online workshops with R8 SIGHT group leaders and volunteers to provide support and guidance to overcome any operational or organizational issues and obstacles they face or could face in the future and to ensure their optimal functioning.

*Status:* R8 SIGHT groups regional report launched to receive feedback from SIGHT groups. The first workshop was organized on 3 June in collaboration with HTB.

## ► <u>Humanitarian Voices</u>

*Description:* Delivers news articles regarding humanitarian activities and initiatives across our Region supported by photos on the field and highlight the achievements of SIGHT groups and inspire volunteers.

*Status:* About 7 articles submitted to R8 News. Our social media presence has been revamped to increase impact. The website has been updated (beta release) and is expected to include more SIGHT stories in the future.

#### ► <u>R8 Humanitarian Awards</u>

*Description:* Part of the Region 8 Awards program and includes two awards (one for Sections and one for Student Branches) to encourage SIGHT Groups to raise visibility and recognize achievements.

Status: Successfully completed this year. Next steps to evaluate procedures for next year improvements.

#### <u>SIGHT Groups Monitoring and Mentoring</u>

*Description:* Gathers statistical and leadership information for R8 SIGHT groups (monitoring) to identify actions needed for each case and communicate them to their leaders (mentoring).

Status: Statistics for H1 were gathered and emails were sent. The process will be repeated for H2.

## ► <u>SIGHT Week/Day</u>

*Description:* The annual international celebration in which SIGHT Groups are encouraged to organize and host their own activities to celebrate SIGHT Day with their members. Our Committee targets to increase awareness of IEEE SIGHT Week/Day and celebrate the impact SIGHT volunteers and groups are making.

Status: A webinar was hosted during SIGHT Day and a challenge was launched for SIGHT groups.

### Humanitarian Meets STEM Initiative

*Description:* Targets to spread IEEE humanitarian efforts and introduce sustainable development goals to pre-university students. The expected outcome is the creation of the "Humanitarian Meets STEM Hub".

Status: Established collaboration with R8 EPICS. Defined promotional options. Content to be created and published by Q4.

# ► <u>Humanitarian Opportunities from Societies Initiative</u>

*Description:* Targets to boost collaboration between R8 HuAC and Technical Societies through partnerships. The expected outcome is the creation of a value proposition of the R8 HuAC agenda to societies (and potentially to industry partners).

Status: Further discussions about planning and executing will take place in Q3/4.
