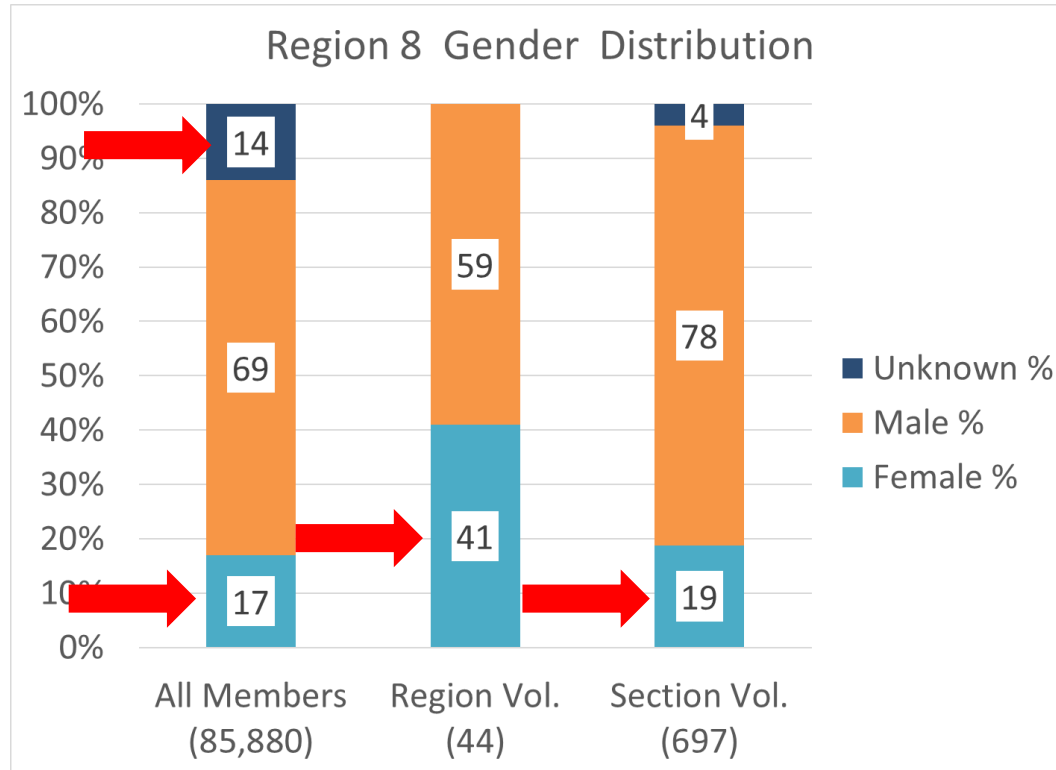

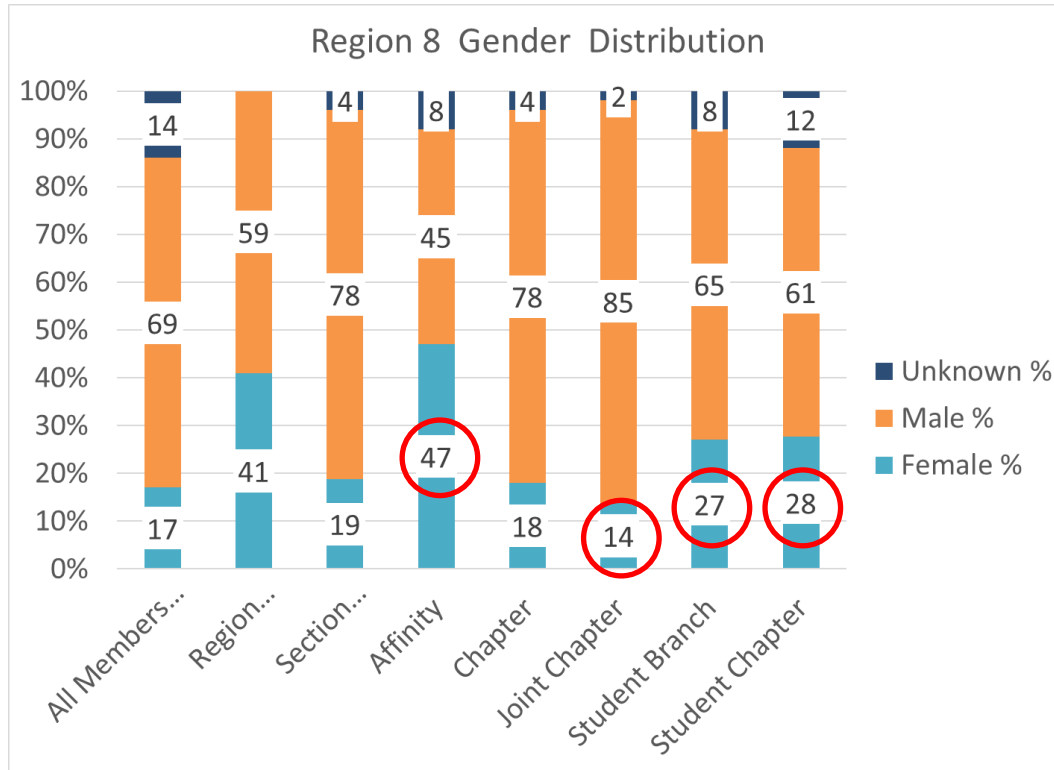

Analyzing Diversity and Volunteer Inclusion (Region, Sections)



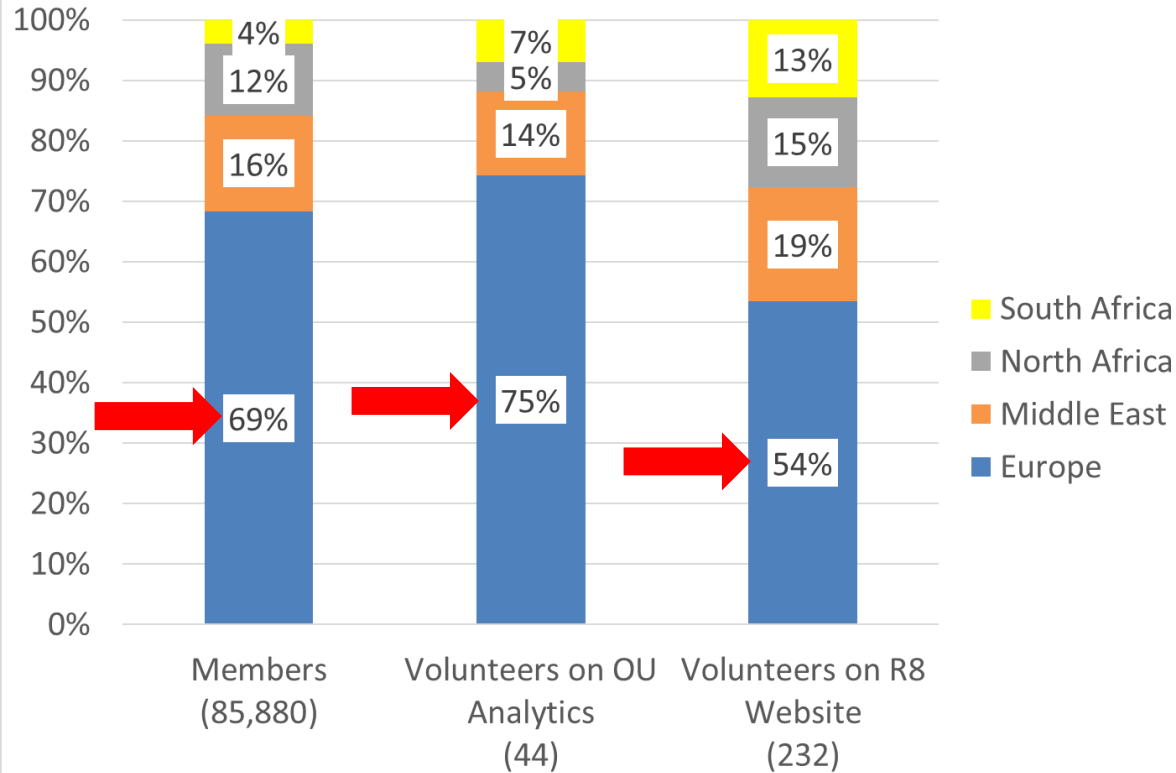

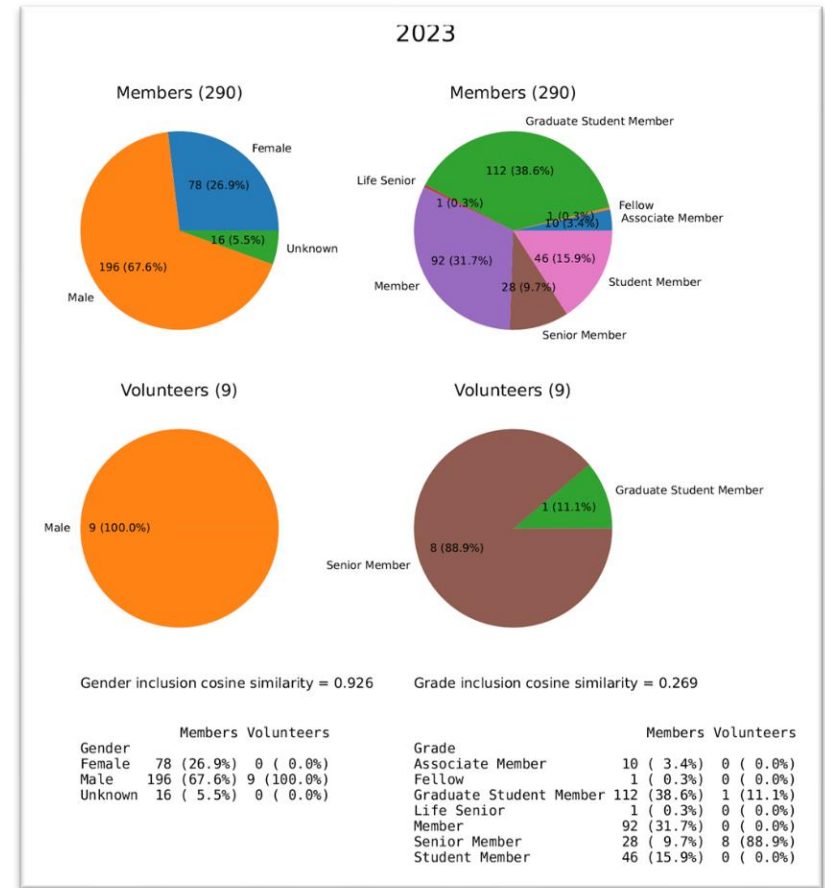
