Section industry Coordination







Industry events & initiatives

The AfI committee is beginning to plan the 2025 Section Industry Ambassador (SIA) training workshops. :

Two regional in-person meetings, the first one of which will take place on 4-6 June 2025 in IEEE EURCO-CON Portugal (Led by Afi team: Mohammad, John, Sohaieb) and the second one one 24-26 August in IEEE RTSI Tunisia (Led byAfl Team Sohaib, Serge, Nihel)

These workshops are designed to train new SIAs, share best practices between IEEE Sections, strengthen connections between Sections, Regions, and IEEE Headquarters with respect to industry engagement, and provide a platform for IEEE leadership to interact with the local industry of the organizing Section.



Other contributions of AfI during these events are to collaborate with Local sections as organizers to schedule other industry activities such as: **industry workshops/panel discussion** with local industry partners and industry visits.

Some selection criteria were set for in-person SIA participation (Due to limited budget, limited places could be provided).

Awards and Recognitions

The Action for Industry Committee is looking to introduce recognitions to highlight the outstanding work done by volunteers and Sections in relation to industry engagement.

2025 MGA surplus Funds- Project proposal (Waiting for approval)

On March 6, AfI Committee submitted a project titled" Reach out to Industry in Sub-Saharan Africa" to request additional funding from MGA

Project Lead: Nihel Ben Youssef, Tiziana Tambosso, Costas Stasopoulos Project Description:

The aim is to reach out to Sub-Saharan Africa which is an underserved area of the World regarding the presence and the penetration of IEEE. Sub-Saharan Africa is the area and regions of the continent of Africa that lie south of the Sahara. These include Central Africa, East Africa, Southern Africa, and West Africa. The total population of this area is 1,137,000,000.

The aim of the industry outreach is to bring together various industries and companies from these countries together in Nairobi Kenya for a two day event. In Kenya we have a strong and active IEEE Section with many volunteers and will be able and willing to organize an Industry event. Various local (Kenya) companies and other companies from around the area,

will be invited to make presentations, show the current and future trends in their area, share career opportunities, discuss possible partnerships etc.

IEEE members and potential non-members from the area will be invited to participate and attend the presentations and workshops. This is indented to take place in October as a two day event and it will be organized with the lead of IEEE Region 8 Action for Industry Committee, the Kenya, Nigeria, Zambia, Ghana, Uganda and South Africa Section. MGA leadership,

IEEE Region 8 leadership and the IEEE Industry Engagement Committee will also be invited to actively participate and engage with members. Also the Section Industry Ambassadors from these Sections will be invited to participate, bringing in their own perspective and attending a workshop.
