## **Committee of R8 Specific Issues 1**

Considering IEEE is one of the world's largest standards organisations, R8 standard coordinator and the R8 standards coordination ad hoc committee play a vital role in educating and promoting engagement about standards within Region 8 members. Therefore our recommendation is that the IEEE R8 Standards Committee is provided a channel to deliver its defined charter by Region 8 and under the technical activities such as participation in annual meetings that chapter coordinators participate in, and quarterly eNotice. This arrangement would facilitate our ability to convene during region 8 meetings and enhance our capacity to deliver improved outcomes.

#### **Committee of R8 Specific Issues 1**

Apart from general awareness raising and encouragement for active participation, the R8 Standards Coordination Ad Hoc Committee could also showcase and promote specific genre of standards in development or recent releases that have major



global and R8 interest and impact such as those in AI, Technology Ethics, Climate Change Adaptation and Mitigation Technologies, Quantum Computing etc.

#### **Points of Concern**

A clear path and process for alignment with IEEE SA must be established at the director level and reflected in the Region 8 Standards Coordinations charter and R8 bylaws and operational manual as necessary.

#### Proposals for improvements/Other Issues to report

The Region 8 SC has conveyed the request from a Region 8 section chair concerning the appointment of a section-level standard ambassador. This request has initiated discussions for a standard ambassador programme, with Region 8 serving as the pilot for this initiative. The details of the programme are still pending and will be shared by IEEE SA with the Region 8 committee in due course.
