#### **Section Elections**

The election of the Section Secretary and Section Treasurer by IEEE UK and Ireland Members via eBallot was concluded on 06 December 2024. The term for the elected Section Secretary and Section Treasurer runs from 01 January 2025 - 31 December 2026.

The Section Vice-Chair was elected in 2023 for the 2024 – 2025 term and will become the Section Chair in 2026.

The next election for the 2026 – 2007 Section Vice-Chair will be undertaken during 2025.

#### **Annual General Meeting**

The IEEE UK and Ireland Section held the 2025 Annual General Meeting as a virtual meeting on 19 March 2025 to facilitate participation from members across our geographically diverse Section. This meeting was well attended. This provided an opportunity to raise awareness of the Sections achievements over the past twelve months as well as current and planned activities. It also provided an opportunity to raise awareness of the Call for Nominations and Election process for the Section Vice-Chair for 2026 – 2007, which will commence in August 2025.

#### **ExCom Meetings**

Two in-person ExCom meetings were held in 2024 – Spring ExCom Meeting on 26 April 2024, Edinburgh and Autumn Section Meeting on 03 – 04 October, Dublin. These meeting were already reported in the R8 report submitted in October 2024.

The Spring in person ExCom Meeting is scheduled on 11 April 2025 in Manchester.

## Membership

Membership of UK and Ireland Section has been relatively stable in recent years, with over 10,000 members.

As at 01 March 2025, OU Analytics reported 11,275 members - c.50% Member Grade; c.15% Senior Member Grade; c.20% Graduate Student Members' and c.5% Life Members.

A key challenge for IEEE UK and Ireland Section is our geographic diversity, with a tendency in the past to concentrate activities around Greater London, with the exception of a rotation of Section Meetings taking place outside London.

During 2024 and 2025, there is a specific focus on engagement with members, student branches, young professionals and life members. This includes organization of membership engagement events and student branch and affinity group events across the Section to support engagement with local members. During 2024 five in-person membership engagement meetings were organized - Edinburgh (25<sup>th</sup> April), London (30<sup>th</sup> September), Liverpool (1<sup>st</sup> October), Dublin (4<sup>th</sup> October) and London (17<sup>th</sup> December). Membership engagement events will continue during 2025 to support in-person engagement with IEEE Members. Dr James Irving provided a virtual lecture on "Open Access and Rights Retention Policy" on 05 December 2024.

The Section Chair has more actively engaged with members providing regular updates on Section achievements, activities, Senior Member elevation and encouraging new volunteers to support a range of Section activities via eNotice, Engage, the Section website and direct engagement during meetings. There was significant engagement with Members during the Call for Nominations and Election process for officers for 24 Organizational Units reporting to the Section from July – December 2024 actively encouraging members to volunteer to support their Chapter, Council or Affinity Group. This level of engagement has continue in 2025 with a number of Chapter and Affinity Group elections currently ongoing.


A report on section activities, achievements and Section, Chapter, Council and Affinity Group officer elections during 2024 was sent to all Section Members in early January 2025 via eNotice and published on the website to ensure that all members are well informed and feel more engaged with the Section.

During February 2025 the Section Chair sent a personalized email to each member who membership had not yet been renewed raising awareness of the membership renewal deadline and benefits. This interaction was appreciated by members.

## **Senior Member Elevation**

During 2024, the Section Chair identified ExCom members who were not Senior Members, encouraged them to apply and supported them to commence the process. Chapter and Councils Chair were requested to actively follow up with Members and support elevation. Direct support was also provided to other Section Members upon request.

During 2024 130 members of the UK and Ireland Section were elevated to Senior Member. An eNotice was circulated to all Section Members in December congratulating these members on this achievement and those elevated were recognized on the Section website.

During February 2025, the Section engaged with Senior Members inviting them to volunteer as part of a Support Panel for Senior Member Elevation. A separate engagement was undertaken with those of Member Grade to raise awareness of the requirements and benefits of Senior Member Elevation. This was followed up by an awareness meeting on 20 February to provide more insight and facilitate questions and discussion. This session was well received with a lot of discussion.

The Section has published a new section on the Section website with information on Senior Member Elevation, links to the recording of the Senior Member Elevation awareness session on 20 February and recognition of members elevated per year from 2020.

The Section is providing active support to members to increase the quality and relevance of submissions for Senior Member Elevation and to support identification of additional references as required.

## IEEE Volunteer Leadership Training (VoLT) Program 2024 Graduates

Three UK and Ireland Chapter / Affinity Group Officers were accepted into and graduated from the IEEE 2024 VoLT program, which ran from September – December 2024:

- Miriam Cunningham (IEEE UK and Ireland SSIT Chapter Chair);
- Ruth Lennon (IEEE UK and Ireland WIE Vice-Chair); and
- Nagham Saeed (Section Vice-Chair).

As part of the VoLT program, participants are grouped into international project teams. They are tasked with coming up with project ideas that are relevant to support IEEE and their Sections, preparing a project business plan and presenting their results within a specific time frame. All projects are then reviewed by the VoLT Mentors and graded.

The "IEEE Industry Hub: Strengthening Professional Communities project" prepared by the VOLT NoVA Team including Miriam Cunningham, Ruth Lennon (UK and Ireland Section), Anjana Dodampe (Sri Lanka Section), Anum Tariq (Lahore Section), Munjandira Chengappa (Bangalore Section), Akhil Raj (India) was awarded 2<sup>nd</sup> Prize in the VoLT 2024 Projects Competition. The concepts from this project are now being implemented in the IEEE UK and Ireland Section.

#### **Students**

The IEEE UK and Ireland Section has 50 registered Student Branches. The section has 32 SBs in England, 9 in Ireland, 7 in Scotland and 2 in Wales.

# **Engagement with Student Branches & Capacity Building Activities**

During 2024 and Q1 2025, the IEEE UK and Ireland Section has intensified engagement with Student Branches, Student Branch Chapters and Student Branch Counsellors as part of our member engagement strategy for 2024 – 2025. The three inperson Student Branch events in London, Liverpool and Dublin with participation of Dr Tom Coughlin, 2024 IEEE President during IEEE Week 2024 were reported in the October 2024 report.

Given the number of student branches and the geographic diversity of our Section, a regional based Committee has been established for 2025 with a specific Committee members with experience within a well-functioning student branch taking responsibility for supporting student branches for Ireland and Northern Ireland; Scotland; Central and Northern England; and Southern England and Wales.

During January 2025, each Student Activities Committee Member followed up directly with the Student Branch officers and Student Branch Counsellors to whom they are providing direct support to explain the reporting processes including Annual Reporting for 2025 and associated deadlines. This was followed up by two virtual Education Activities/Capacity Building activities:

- Student Branch Officer Training, 27 February 2025
- Student Branch Activities, 06 March 2025

A number of Regional in-person knowledge sharing and capacity building activities will be organized during 2025 to supplement virtual activities. This strategy is focused around supporting collaboration and knowledge sharing between Student Branches and Student Branch Counsellors.

Student Branches are being encouraged to adopt a city-wide approach to organization of events, to achieve greater scale and impact and to achieve regular rotation between universities providing free venues. They are also being encouraged to actively



engage with technical chapters to access IEEE Distinguished Lecturers for both in-person and virtual technical events. This is a key way of ensuring a high level of technical events and encourage students to retain membership after leaving university.

The members of the ElectroWarriers Team, Maynooth University were Adil Farooq, Tadhg Creagh, Eoghan Mooney, mentored by Peter Redmond.

## Women in Engineering

An election of Women in Engineering AG Officers will be undertaken during 2025 for the 2026 – 2027 term.

WIE has organised three training sessions on "Team Working and Development" during October 2024. WIE submitted a bid to host WIE ILS 2025 in 6 cities across the Section, which was successful.

On 11 February 2025, WIE co-hosted a lecture by Prof Hatice Gunes on "Social Alignment in Robotics: Promoting Human Wellbeing Through Adaptive Robotic Coaches" in the context of Girls and Women STEM Day in cooperation with IEEE UK and Ireland RAS and SSIT Chapters.

2025 Plans include



- Organising WIE ILS 2025 in London, Nottingham, Liverpool, Leeds, Letterkenny and Limerick.
- Supporting leadership training.
- Ongoing active Early career talks Ambassadors scheme

#### Young Professionals

During 2024 the Young Professional Affinity Group undertook officer elections for the Chair, Vice-Chair and Secretary for the 2024 - 2025 term.

The Young Professionals aim to build on current success and volunteer base from existing events to further reach out to members across the section with a mix of both virtual and co-located in-person events organized with IEEE conferences and membership engagements events across the Section.

From October 2024 – January 2025 the Young Professional AG co-organised six guest lectures in cooperation with the IEEE UK and Ireland APS/MTT Joint Chapter as well as two Career events sharing insights from Academic and Industry speakers.

The UK and Ireland Section has 31 Chapters and 3 Technical Councils.

## **Elections / Compliance / Chapter, Council Election Support**

During 2024, **20** Chapters, **3** Councils and **1** Affinity Group (YP) undertook officer elections with voting by OU Members via eBallot.

There are **7 Chapters** and **1 Affinity Group** whose officers terms expired in December 2024 and are due to undertake elections for the 2025 – 2006 term. Since January 2025, four Chapters and 1 Affinity Group are currently undergoing elections and these will be finalised during March and April. Three Chapters have not yet commenced the call for chapter election Committee Members or Call for Nominations.

Completing this scale of elections was only possible based on support provided by a small number of dedicated local volunteers who held individual briefing meetings with each Chapter/Council/AG Elections Committee, prepared standard documentation for the call for nominations and election process (Standard eNotice to invite volunteers to serve on a OU Elections Committee; OU Elections Committee Meeting Agenda; OU Officer Role Description; OU Officer Application Form; Call for Nominations eNotice), providing support to the Elections Committee as required including circulating eNotices to OU members and training on setting up slates in vTools eBallot.

## **Chapter Education Activities / Capacity Building**

The IEEE UK and Ireland Section provides active support to Chapters, Council and Affinity Groups on an ongoing basis. Capacity Building Activities organised to date during 2025 include

- OU Officer Training, 29 January 2025
- vTools Training, 06 February 2025

The IEEE UK and Ireland Section has actively engaged with industry and government stakeholders as well as Sister Societies during 2024 through a number of complementary activities including supporting Senior Member Elevation, organising a series of public engagement meetings during IEE Week 2024 on topics relevant to industry and government as well as engagement with Sister Societies in Ireland (Engineers Ireland) and United Kingdom (IET).

In February 2025 the Section launched a Call for Volunteers to support Industry engagement with a good response from industry, government and education and research sectors.

The Section Industry Engagement Volunteer team will facilitate industry and government engagement activities, including
