Subcommittee Specific Issue

1. Support of the student and YP activity

LMSC informed the Student Activity Team and Org Committee the Region 8 Student and YP Congress 2022 about the co-operation with LMAGs and support opportunities of IEEE LMC.

Points of Concern

1. Officer Rotation

LMSC proposes Region 8 MA to better observe the officer service term of 2-years. Administrative process is needed to develop the rotation culture. Long-time serving LMAG chair is one of the reasons of inactivity of the LMAG.

Proposals for improvements

- 1. The LMSC will continue its activity and cooperation with Section to establish new LMAGs. There is a high potential to create new LMAGs in 20 Sections.
- 2. LMSC will encourage LMAGs and other Regional OUs to apply for financial grants to support LM activities and special projects.
- 3. LMSC will encourage LMAGs to involve active IEEE members approaching LM status into the LMAG activity.
- 4. LMSC is planning an LMAG Chair meeting in conjunction of either the Spring or Autumn 2022 R8 Committee meeting, depending on the COVID travel restrictions.
